Right On! Frank I submitted this letter yesterday to the local media... sorry if this is the 2nd time you have rec'd it.....

2 AM staring at the ceiling wishing I had not opened the slider to let the spring air in before I got into bed. Not because it is cold out, because it is not. But because I had forgot.

I forgot that our Neighbor has more rights than us. Our neighbor can spin 24 hours a day without care but we can't open our windows.

We pay our taxes but don't have the right to open our windows? We have been here 17 years and Wind 1 has been here 14 months but it's a privilege not a right to sleep through the night uninterrupted.

You see, I forgot.

I forgot that the Town of Falmouth in the haste toward Green Energy didn't do their due diligence and sacrificed the property owners living peaceably on Firetower and Blacksmith shop roads. I was lulled into a happy ignorance because ... there is a moratorium on new projects for Turbines, and the Cape Cod Commission has established regulations so there is movement to save neighborhoods from industrial sized turbines. And thank you God to the Select Board who established the 23 mile an hour shut off rule. But I forgot that even with movement toward saving other communities from these offensive Neighbors, we are still "collateral damage".

I forgot that I no longer have a right to an uninterrupted nights sleep. Sacrificed for the "greater good".

I stare at the fan between the recessed lighting and listen to the thud, thud, thud of my neighbor. I wonder who else is up? I suppose the Andersons are, certainly the Elders, probably the Eddy's or the Drummy's... it is 2:30 am...then it is 4:00...now it is 4:30 and the alarm goes off for my husband to go to work as an air traffic controller. I guess he doesn't need to sleep, at least, not according to the Town.

I just forgot that we don't have the right to sleep a full night in our home anymore. I forgot that every season brings a new "annoyance" from our neighbor as the wind directions change.

I write because, well, I thought maybe Falmouth has forgotten too. We are still here, sleepless.
